 Each school is allowed 6 athletes per event
 Each school is allowed 1 relay team per relay
 Athletes are allowed to compete in up to 4 events

Awards: Awards will be given to the top Six Finishers in individual events and 1st place relay teams.

Coaches, As you register your athletes for their events, please estimate a reasonable mark for the athletes so they are placed in the appropriate heats and sections. We will run events and sections in slow to fast and short to long order. Although the Medley Relay event is being contested for the smaller classifications as a state qualifying opportunity for them, all schools are welcome to run a medley relay team.

Updated Covid information will be posted by Tuesday evening if anything changes from the current mandate from the State:

With the statewide mask mandate ending on April 10th, this message serves as a reminder that UHSAA sanctioned events fall under K-12 jurisdiction, which states that mask mandates will remain in-place until June 15. Local officials, such as school boards or UHSAA boards, do not have legal authority to end the school mask requirement until this date. Additionally, mask requirements will remain in place for group gatherings of 50 or more people.

There will be \$2 entrance fee for spectators. Please put your canopies on the grass outside of the fence on the north side of the stadium.
